



MEMBERS' BADGE DRAW - Procedures & Terms

DBCYA operates a free entry lottery promoted to the members as The Badge Draw (The Draw) every Wednesday under the following terms and conditions:

1. Draw Particulars

The Draw is conducted every Wednesday evening and announced over the DBCYA PA system by the Promotion Host (the DBCYA Rear Commodore or their appointed delegate). The Draw particulars are displayed on the DBCYA entertainment chalkboard preceding each Draw.

The Draw commences at \$500 and increases \$50 each week that it is not claimed, until it reaches a value of \$1000. The Draw will then remain at this figure each draw until claimed. Upon the Draw not being claimed at \$1000 a second Draw will commence the following week as per the terms of the first Draw, to run concurrently with the first Draw. Both the first and the second Draws will be announced at 7:45pm or as close to as possible.

Should both Draws be unclaimed at \$1000, a third Draw will commence as per the terms of the second Draw, excepting that this Draw may be conducted within the times of 7:45pm and 9pm, with prior advice of the Draw time required (via the Club entertainment chalkboard and SMS and/or email) if to be conducted at a designated time later than the first and second Draws.

The DBCYA Management Committee may on occasion pass a motion to conduct an additional one-off Draw for a special club occasion or to encourage patronage, at a set value determined by the Management Committee.

2. Eligibility Criteria

2.1 To be eligible for the Draw a person must:

- Be a financial DBCYA Life, Full, Sail Crew or Social member (includes pensioner);
- Be at least 18 years of age;
- Be present at the DBCYA licensed premises for the purpose of patronising the venue (drinks and/or meal);
- Be in attendance within the confines of the DBCYA licensed premises when the member draw is announced; and
- Be able to announce their attendance within the licensed premises to the Promotion Host within 60 seconds.

Note: A person who is already in attendance at the licensed venue but has momentarily stepped out of the licensed premises for the purpose of ordering dinner or visiting the ablutions will be considered eligible for the draw if they meet all other eligibility criteria.

2.2 Persons Ineligible for the Draw:

- Persons who are not DBCYA financial members, including persons whose recent application for membership has not yet been ratified by the Management Committee or lapsed members who have not paid their renewal fee for the current membership period;

- A financial member within the club grounds (including the DBCYA hard stands, careening poles, workshop and laundry) but not patronising the licensed premises when the Draw is announced as per item 2.1;
- Kitchen contractors and their staff working a shift in the Galley when the Draw is announced;
- DBCYA staff working a shift in the Bar when the Draw is announced;
- Any contractors (eg musicians) engaged to perform a paid service in the licensed premises the evening a Draw is conducted; and
- The DBCYA General Manager.

3. Process to select the weekly winning Draw number/s

The Draw number/s will be selected randomly through the Club's computerised membership system, facilitated by the Promotion Host. All eligible financial members shall be included in the Draw number selection.

The Promotion Host shall endeavour to find a willing non-member in attendance to click on the mouse once to generate the winning number. In the absence of a willing non-member, The Promotion Host will select a member to conduct the draw, in the presence of a bar staff member as a third witness.

The first number drawn shall be that used for the Draw. If a second Draw is also operating, the Promotion Host will, at the same time, also oversee the random generation of a second number and this number will be applied to the second Draw. If a third Draw is also operating an additional number will be generated as per the process above.

The Promotion Host will record the winning member name/s and member no/s in the Badge Draw register.

The winner's name/s will be displayed on the DBCYA entertainment chalkboard for a week and may be displayed on social media in conjunction with promoting the Club's entertainment.

4. Claiming the Draw prize money

Upon completion of the draw the successful Badge Draw winner is to present at the bar and verify their identity with their membership card or photo ID to claim their prize. The winner will receive a cash payout from the bar or can opt to have their winnings deposited by EFT transfer upon provision of their bank account details. All winners opting for cash must sign the Badge Draw register to confirm receipt of their prize winnings.

5. Complaint Process

The Promotion Host's Badge Draw winner decision is final and no correspondence will be entered into.
