## **Television Screening Policy**



#### 1. Background

DBCYA has one television (TV) that is capable of screening free-to-air channels. This TV can also be used to display video taken of the Wet Season Race Series and other club footage as deemed appropriate. Historically the club has adopted a stance of minimal use of the TV however is now opting to allow more sport to be screened following a member survey in November 2022 (the survey) that showed the majority of members were happy for this to take place in some capacity.

#### 2. Purpose

The purpose of this policy is to:

- 2.1. Set fair permissions and boundaries of what can and cannot be screened in consideration of the wishes of all members,
- 2.2. set clear guidelines for staff operating the TV, and
- 2.3. offer members a reasonable selection of feature sporting events for their entertainment, based on preferences indicated in the survey.

#### 3. Screening Limitations

- 3.1. All television viewing is to be without sound.
- 3.2. Only events on free-to-air channels can be shown.
- 3.3. Live music and club events take priority unless by prior approval of the General Manager, the TV will remain turned off whilst any live music or club events are taking place. If already turned on, the TV will be turned off within 15 minutes of a live music event or club event commencing.
- 3.4. The TV shall only be turned on at member request permitted sport games will not automatically be screened.
- 3.5. The TV shall only be turned on at the advertised start time of a game (which can include lead-up) and will be turned off once that game has finished or as per item 3.3.
- 3.6. Any special sporting or significant events not listed below that are considered of substantial importance to a sufficient amount of members may be screened at the discretion of the General Manager.
- 3.7. The following will not be screened:
  - 3.7.1. Matches of sport codes that scored less than 8 survey votes (refer pg 3) ie netball, cycling, basketball and golf plus matches of less popular codes such as badminton, chess, darts, horse racing etc
  - 3.7.2. Seasonal / preliminary rounds of any sport codes
  - 3.7.3. News programs and other programs not considered relevant to a yacht club
  - 3.7.4. Any games that screen outside of DBCYA's licensed venue operating hours

### 4. Television Operation

- 4.1. DBCYA staff shall maintain control of the TV operation at all times.
- 4.2. DBCYA Bar staff do not have the authority to deviate from the terms of this policy.




